MY DEFINITIONS

CU:

CU means you can use my CU items for products that you sell, however those products **MUST** be sold as **Personal Use Only**.

CU4CU:

CU4CU means that you can use my items in products that you sell, and you can sell your kit as CU to the person who buys the product from you. You **CANNOT** transfer the CU4CU license to them. They cannot offer CU to whomever buys their product – their customers must use it as PU only.

Only designers who have purchased my previous CU Designer Stash license or those who have purchased my new CU4CU can sell as CU. The new CU4CU license allows designers to sell products made from my scripts and templates as element packs.

TERMS OF USE - Please read completely before using these items:

PROHIBITED USES:

ANYONE WHO HAS BEEN BANNED FROM ANY OF MY STORES ARE NOT ALLOWED TO PURCHASE OR USE ANY ITEMS THAT HAVE BEEN CREATED AND UPLOADED TO MY STORES SINCE THAT TIME.

You may not do anything with my product that is not expressly permitted. You may not provide a copy of my product, or any portions thereof, to anyone or allow anyone to gain access to my product, or any portion thereof.

YOU MAY:

(a) Use these items for your own personal use or to sell as personal use only, unless you have

purchased my previous CU designer stash license or my new CU4CU 2016 license. You may also use the products in blog trains or collabs as long as they are for personal use only and as long as no more than 10% of my products are used. Free element packs are NOT allowed.

(b) Colorize, add to, take away from, and/or resize to fit your project. Please try and make changes to the item where possible

(c) You may now use my items for S4H/S4O

(d) You may use these items to create craft printables, greeting cards, for use on sites such as craftsuprint.com and Zazzle.com. Items used on these sites MUST be flattened to one layer. Element packs are allowed if you have purchased my 2016 CU4CU license. Please credit me in your TOU included with your downloads and on each product page that you sell the item on. You may use my products to create derivative designs in digitally downloadable cardmaking templates, backgrounds, vellums, toppers, pyramage, and decoupage, including placing the original image which has been used in your derivative craft sheet as a discrete, separate element on the craftsheets. If everything is merged into jpg craftsheets of no more than 150 dpi. There is no extended license required for this usage.

(e) You may use my products to create “designer cache” kits, only if you have previously purchased my CU license. These cache's must contain no more than 30% of my products, and must not be ONLY elements, you must include papers, frames, etc. Please try and change the item somehow, where possible. – the 30% allowed does NOT include papers. Your preview must state how many elements and how many papers are included. I no longer sell the designer stash license. If you purchase my new CU4CU license 2016, you can make element packs as well.

(f) You may use my products to create signature tags that you give away freely – please credit me where possible.

(g) You may now use my products to make blog and store layouts – the items must be merged into one layer.

(h) You may now use my products to create stencils for use as stamps.

(i) You may now use my products to make candy wrappers, bag toppers etc.

(j) You may use up to 10% of my products in a freebie kit, if that kit is for personal use only.

YOU MAY NOT:

(a) claim my products as your own.

(b) sub-license, re-sell, rent, lend, or otherwise distribute my products;

(c) post a copy of my products on a network server or web server for use by other users;

(d) make any products into tubes, brushes or scripts and redistribute them in any way, including freebies.

(e) use tubes specifically designed for use with particular scripts/templates in other projects.

(f) use more than 30% of my product elements in any one project, unless you have purchased my Unlimited Usage license – make sure you read the TOU of the license as well.

(g) sell my items in element packs – unless you purchase my new CU4CU 2016 license.

(h) use my images with adult content, for unlawful or other immoral purposes, for spreading hate or

discrimination, or to defame or victimize other people, societies, cultures.
